

**QUESTAPALOOZA 2011 EXHIBITOR
GUIDELINES and POLICIES**

- Exhibitors may only setup or operate at Questapalooza (QPZA) with the express written consent of Quest Community Church.
- The date for QPZA this year is Saturday, September 3, 2011. Festival hours are from 2-9:30PM; however exhibitors will only be open from 2-8PM.
- **A non-refundable entrance fee of \$150 per exhibitor is required.**
- Exhibitors will be outside without a tent for covering/shade. Exhibitors are allowed to bring a tent/shade that is no larger than 10X10. You will also need to bring your own 6ft table as well as power chords. If additional space is needed for your exhibit you may request such in the application below.
- Quest Community Church is not responsible for theft or damage. All exhibitor materials are the responsibility of the exhibitor.
- Exhibit location assignments are at the discretion of Questapalooza leadership and will be communicated upon arrival.
- Exhibitors are responsible to provide own staffing. All exhibitor workers must have a ticket to Questapalooza. Tickets may be purchased at www.qpza.com .
- Please indicate on the application the names and contact information of people with your organization who will be staffing the exhibit booth.
- All exhibits are required to be completely set-up by **12:00 PM on Saturday, September 3, 2011**, or you will forfeit your spot.
- **All exhibitor booths must stay open from 2:00 PM – 8:00 PM.**
- All exhibits must come down by 11:00 PM. You may not leave any part of your tent structure, tables or marketing materials behind.
- Quest Community Church is an evangelical Christian community striving to create an atmosphere that honors Christ and conform to Biblical precepts of faith and moral values. If any of the items in an exhibitor's space are deemed to be inappropriate or incompatible with this goal, the exhibitor will be asked to remove them.
